


Liability waiver for cats and dogs transport in the hold (AVIH)




Maximum dimensions of the container:
Length: 120 cm (47 in)
Width: 81 cm (32 in)
Height: 89 cm (35 in)
Maximum weight: (including the animal)
75 kg (165 lbs)

Accepted containers for your animal:

- ✦ A. The container (cage) must have adequate ventilation on 4 sides.
- ✦ B. If you transport a cage with wheels, the wheels must be removed. If they are retractable wheels, block them with adhesive tape.
- ✦ C. The container must be rigid (plastic or fiberglass). Soft bags are not accepted in the aircraft hold.
- ✦ D. The bottom of the cage must be covered with absorbent towels or blankets. (straw, hay or wood shavings are prohibited).
- ✦ E. Food and water dishes must be attached to the inside of the cage door and also accessible from the outside. No accessories should be left in the cage, the cat/dog must not wear a leash or muzzle.
- ✦ F. The (grill) door must have a central locking system that locks in two places: at the top and bottom of the door.
You are requested to add 4 zip ties before sending the cage (not provided by the airline)
- ✦ G. The door hinges must extend beyond the horizontal extrusions located above and below the door by 1.6 cm.
- ✦ F. The two parts of the container must be fastened together with bolts.

Acceptance conditions of animals:



- ✦ The dog (if applicable) does not belong to categories 1 or 2, as defined under French regulations.
- ✦ The cat/dog can't travel if sick, injured, weak or under tranquilizer.
- ✦ The cat/dog must be able to stand with its head fully upright, without touching the roof of the container. The height of the container must therefore be more than 5 cm higher than the height of the animal in the standing position from the top of the ears or the head. Your cat/dog should also be able to turn around and lay down comfortably
- ✦ 2 adult cats or 2 adult dogs can cohabit the same cage provided they are of comparable sizes, weigh less than 14 kg per animal and follow the same cage conditions as defined above.

I, hereby certify that, as the owner of the animal, that:

- ✦ My dog or cat's transport container complies with the above standards. My container is in perfect condition, adapted to the size of my animal and equipped with an effective locking system and zip ties that I myself put on the cage.
- ✦ I understand that it is my responsibility to be aware of all regulations that are in effect in the countries of departure, arrival and connection (vaccinations, quarantine, etc.) and certify that I am in possession of all the identification and health documentation necessary for my animal's trip (non-exhaustive list: Vaccination booklet, European pet passport, for travel within the European Union, etc...)
- ✦ I understood that French bee reserves the right to refuse to transport my animal and will not be liable for any costs incurred in the event of failure to comply with these conditions. The same will apply in the event of refusal to accept the animal upon arrival, if justified by non-compliance with the regulations of the destination country
